

ADDENDUM NO. 03

NOTICE TO ALL DOCUMENT HOLDERS:

The following additions, deletions, changes and clarifications to the drawings and specifications are to be included as part of the Contract Documents.

GENERAL

ITEM NO.1 PRE-BID

A pre-bid meeting was held at the Office of the Madison County School District at 10:30 am on Thursday, April 22, 2021. The Sign-In Sheet is attached.

ITEM NO.2 APPENDIX A | Subsurface Investigation (issued in Addendum No. 02)

All work, including but not limited to, excavations, trenching and backfilling, subgrade preparation, filling, and rough and finish grading shall be in conformance with the geotechnical report "Geotechnical Exploration Football Field Improvements Ridgeland High School" by Burns Cooley Dennis, Inc. dated April 21, 2021. The contractor shall include, in his base bid, all work in conformance with the requirements on the geotechnical report. Any discrepancies between the geotechnical report and contract documents shall be brought to the attention of the architect prior to commencing construction activities.

SPECIFICATIONS

ITEM NO.3 SPECIFICATION 00.4100 | Bid Form

REPLACE: The bid form shall be replaced by the attached updated form. This updated form includes lines for the verification of 3 addenda. The use of the older bid form is acceptable, if bidders write in the receipt date of all 3 addenda.

ITEM NO.4 SPECIFICATION 01.1000 | Summary

Part 1, Paragraph 4.E Time Restrictions

CLARIFICATION: The contractor may work prior to and after the hours posted, including weekend work with the Owner's approval, and as allowed by City of Ridgeland Ordinance. The Owner has also authorized the use of field lights (subject to an agreement with the Owner for payment of electrical utilities provided per Section 01.5000, 2. A.) to aid in this after-hours work.

ITEM NO.5 SPECIFICATION 01.4000 | Quality Requirements

Part 1, Paragraph 4.A.

CHANGE: The Owner will employ and pay for the services of the independent testing agency as outlined in this paragraph and associated specifications.

DRAWINGS

ITEM NO.6 SHEET C111 | Demolition Plan

ADD: Underground Electrical shown on this drawing it to be located as noted on the demolition plan. Additionally, the Contractor is to include costs for the replacement/relocation of existing electrical utilities that will be disturbed by the over excavation process.

ITEM NO.7 SHEET C131

CLARIFICATION: Collector drains shall tie into intermediate structures to provide constant flow across field and track side of catch basins. Plan currently shows connecting to longitudinal sides of catch basins for clarity. However, the contractor shall ensure a continuous collector pipe trench is provided along each side of catch basin, typical.

ITEM NO.8 SHEET C202 | Drawing 4

ADD the following Notes:

- 1. Collector drain trench shall extend a minimum 18" below No. 57 stone. All stone preparation and placement shall be in accordance with requirements of field turf and base manufacturer and all geotechnical requirements.
- 2. Contractor to inspect and perform percolation tests to determine percolation rates of existing collector trenches in accordance with the requirements of C111. The contractor shall coordinate with the geotechnical engineer to observe and provide results of percolation tests.
