No oral or telegraphic bids will be considered.

- Bidders are required to have their certificate of responsibility on the face of the envelope and proposal form. A certificate of responsibility number is required for any subcontractor that is contracted for more than \$50,000. Subcontractor name is required to match the name registered with the MS Board of Contractors.
- Work conditions specific to MCC's Campus are outlined in the specifications
- MS State Laws & Regulations apply to this project
- Bidder is required to acknowledge all addendums on their Bid Form



- There will be a 24hr period prior to the bid opening for protests and errors. Must be submitted in writing.
- The 5% bid security will be relinquished if the low bidder fails to enter into a contract prior to award.

The Project includes the construction of:


- 8 Tennis courts with associated amenities: bleachers, seating, lighting, fencing, etc.
